

NICHOLAS VAN DE GRIFT KARSTENS DRAWINGS

NASM Archives Accession Number 1987-0096

Nicholas Van de Grift Karstens (1913-1987) was an engineer and draftsman who worked for Douglas beginning in 1937. From the mid-1970s he executed a number of detail drawings of aircraft from the early days of aviation. This collection consists of 16 ink-on-polyester detail drawings. **Most drawings are approximately 30"x40" in size.**

HOW TO ORDER ITEMS FROM THIS COLLECTION:

1. Complete the "Ordered By:" and "Ship To:" blocks below. All drawings going to an address in the continental United States will be shipped via UPS, so it is essential to include a street address to which UPS can deliver. If you prefer to have your drawings shipped via U.S. Mail, you must specifically request this service (the shipping cost will be the same).
2. Mark the number of copies you would like of each item in the first column (marked #) of the table on the reverse of this form. Please note that most of these drawings consist of more than one sheet of paper; the full set of sheets for an aircraft type is considered to be **one item**. The price for the item is given in the column marked **Cost**.
3. Add up the total number of ITEMS ordered, and enter the total in the box marked **No. Ordered**. *Because of the large number of orders we receive and the limited staff available to fill these orders, you may request no more than 10 items per order and may have only 1 order in process at a time.*
4. Add up the COSTS of the drawings ordered, and enter the total in the first box of the **Amount** column.
5. Refer to the NASM Archives Shipping Rates form and enter the charge shown in the **Shipping Amount** column.
6. Add up the prices shown in the **Amount** column and enter this total in the box marked **TOTAL**. This is the amount you owe for this order.
7. Complete the PAYMENT METHOD block below and send this packet and your payment to the address below. Please allow four to six weeks for your order to be filled.


